Fair Board assume NO responsibility for losses or injuries for any reason.

What Can be Served/ Sold You can do tastings as well as sell wine/ spirits by the glass or sealed bottle.

Acquiring Vendor Space

- No spaces will be reserved until \$100 fee is paid for in full. • Electric hook up and water available upon request.
- No weather-related refunds or credits. • Cancellation refunds require minimum 15-day notice.

We further agree to obtain a Festivals Permit from the Indiana Alcohol Tobacco Commission, and to limit complementary pours to one (1) ounce. If we sell wine by the bottle, agree to do so for carry-out only, and under no circumstances will we open a bottle at the Wine Fair. We understand that we may also sell wine glasses, t-shirts, wine paraphernalia or other such items, but agree NOT to sell any food. We authorize the Corydon Extravaganza to use our name in promotional literature, news releases and advertisements, and to create links to our web site. We hereby indemnify and hold the Corydon Extravaganza, its partners, employees and managers, harmless from and against any negligence on our part, or our failure to abide by any applicable law, rule or regulation pertaining to the on-premises consumption or carry-out sale of alcohol.
